1	The total number of sections of the school shall be restricted to 26 as per the number of sections reported during inspection, of which not more than 1/3rd sections may be used for senior secondary classes and further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law subject to availability of class rooms of greater than 500 ft dimension.
2	The school does not have ramp at the ground level and has converted regular cubicles into CWSN toilets, but they are very small and narrow and there is no room to negotiate the movement of wheelchair/walker. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be
